

Tax credit is currently available for homes sold or leased in **2016-2020**.

The 45L is a federal tax credit available to **builders** who financed the construction of new energy efficient homes and then sold or leased them.

For each home that qualifies **the builder will receive a \$2,000 per home tax credit** to be applied in the taxable year that the homes sold/leased.

How much is the 45L Tax Credit?

\$2000 per qualified single or multi-family dwelling unit.

What are the 45L requirements?

- Single-family dwellings and multi-family dwelling units for sale or lease which are three stories or less above grade.
- Homes must be at least 50% above the 2006 International Energy Conservation Code (IECC).
- Features verified by 45L Eligible Certifier, such as Quality Built.
- Homes completed & sold (close or escrow) or leased in 2016, 2017, 2018, 2019, and 2020.

**Can builders amend their taxes
to claim the 45L credit?**

Yes. Generally, tax filings can be amended up to three years from the date of the tax filing. For instance, if a builder filed their 2016 taxes on 4/15/17, they usually have until 4/15/20 to file a tax amendment to claim the credit.

**Can projects not currently meeting
50% above 2006 IECC still qualify?**

Yes, Quality Built inspections and diagnostic tests may be used to increase energy features. Quality Built inspections need to be performed and pass in advance of the 45L certificate date. Contact Quality Built for more details.

Who can claim the 45L Tax Credit?

The builder/developer of the homes: the "entity" that owns the structure when it was built and financed its construction qualifies for the credit. If owned by multiple investors, the credit is usually passed through to each investor.

Must all homes in a project qualify?

No. The 45L Tax Credit is per home (per address).
